# FC MACHIDA ZELVIA Match Management Regulations

## Article 1 (Purpose)

The purpose of these regulations is to ensure the smooth and safe operation of match venues hosted by the Japan Professional Football League (hereinafter referred to as "J.League") and managed by our club (FC Machida Zelvia), as well as to ensure the safety of spectators, players, referees, team staff, and all other related parties, as well as the safety of areas managed by the managing club.

## Article 2 (Definitions)

The meanings of the terms listed below shall be as set forth below.

- (1) "Main Match": All matches managed by the Main Match Administrator.
- (2) "Facilities, etc.": Stadiums and other facilities where Main Matches are played, including all areas managed by the Main Match Administrator, both inside and outside the stadium.
- (3) "Spectators, etc.": All persons present at the Facilities, etc.
- (4) "Operation Manager": The person responsible for the operation of Main Matches. In the case of J.League clubs, this would be an Executive Committee member or Deputy Executive Committee member.
- (5) "Operation Officer, etc.": Operations and security personnel appointed by the Operation Manager to ensure safety at Main Matches.
- (6) "Security Personnel": Persons appointed by the Main Match Administrator to ensure safety at Main Matches.



### **Article 3 (Prohibited Items, etc.)**

Spectators, etc. are prohibited from bringing any of the following items into the facilities, etc., except when deemed necessary by the organizers or organizers:

① Items that the organizers or organizers determine will interfere with the progress of the competition, such as fireworks, firecrackers, smoke bombs, smoke bombs, firearms, swords, poisonous substances, and other illegal items, dry ice, air guns, spring-loaded guns, gas horns, cheer horns, vuvuzelas, bottles and cans, drones, cooking utensils, laser pointers, pets (excluding assistance dogs such as guide dogs, hearing dogs, and service dogs), and audio equipment.

② Bulletin boards, signboards, banners, streamers, flags, placards, bibs, documents, drawings, printed matter, and any other similar items that the organizers or organizers determine to fall into the following categories:

1. Items that display or evoke political, ideological, or religious doctrines, claims, or ideas.
2. Items that contain discriminatory or offensive content or language.
3. Items that are not recognized as being intended to support or inspire players or teams.
4. Other items that are recognized as inappropriate according to social standards.
5. Items that display the name of a specific company or product with the purpose of promoting a specific company or

③ commercial enterprise. (This includes, but is not limited to, items that are reminiscent of a specific company, product, etc.)

④ Items other than those listed above that the organizer or supervisor has clearly stated in advance as prohibited.

⑤ Other items that the organizers or security personnel have determined may cause inconvenience or danger to others. (This includes items that the organizers or security personnel have clearly stated in person as prohibited.)



#### **Article 4 (Prohibited Acts)**

Spectators, etc., are prohibited from engaging in any of the following acts at facilities, etc., except when deemed necessary by the organizers or organizers.

- ① Throwing objects onto the field or jumping onto the field.
- ② Entering the stadium without a valid ticket or pass, or entering despite being prohibited from entry.
- ③ Protest rallies, demonstrations, and other acts that may disrupt the smooth running of the match.
- ④ Entering facilities, etc. while intoxicated due to the influence of alcohol, drugs, or other substances that may impair sound judgment, or becoming intoxicated at facilities, etc., and disrupting the running of the match or the actions of others.
- ⑤ Soliciting, speeches, rallies, proselytizing, signing petitions, conducting surveys, and other acts other than those intended for the purpose of spectating the match.
- ⑥ Driving or parking vehicles or bicycles outside designated areas.
- ⑦ Commercial activities, soliciting donations, posting advertisements, etc.
- ⑧ Disposing of garbage or other waste outside designated areas.
- ⑨ Distributing all or part of audio or video from a match via the internet or other media.
- ⑩ Discriminatory, insulting, or otherwise socially inappropriate statements or actions regarding race, skin color, sex, language, religion, politics, or origin.
- ⑪ Summoning a match organizer or other person without valid reason to request an explanation of spectator rules.
- ⑫ Violence, destruction of facilities and equipment, theft of other people's property, or other acts that violate laws and regulations.
- ⑬ Use of whistles, whistles, or other items deemed to interfere with the progress of the match.



⑭ Displaying banners outside designated areas, or removing or damaging opposing club banners without permission.  
Use of drums or other noisemakers outside designated areas.

⑮ Smoking outside designated areas, smoking while walking, or throwing cigarette butts.

⑯ Use of confetti or paper streamers.

⑰ Use of loudspeakers or other equipment for purposes other than directing cheering.

⑱ Unauthorized entry into areas restricted by the organizers/organizers.

⑲ Actions that destroy or damage facility equipment, or operate it recklessly.

⑳ Installation of tents, huts, or similar structures without the permission of the organizers or facility manager.

㉑ Actions that cause nuisance to local residents, or actions that the organizers deem to be nuisances.

㉒ Actions other than those specified in the preceding items that the organizers or organizers have explicitly prohibited in advance.

㉓ Any other actions that the organizers/organizers or security staff deem to be contrary to public order and morals, or that may cause nuisance or danger to others. (This includes actions that the organizers/organizers or security staff have explicitly prohibited in person.)



## **Article 5 (Compliance Regulations)**

Spectators, etc. must comply with the following:

- ① Present tickets, identification, passes, etc. when requested.
- ② Comply with requests for baggage and other personal belongings inspections to ensure safety.
- ③ In the event of an incident or accident, or if one is expected to occur, follow the instructions, guidance, and direction of security personnel or law enforcement authorities.
- ④ Abide by the "Spectator Manners & Rules/Banner Display Rules" listed on the FC Machida Zelvia official website.
- ⑤ In the event of damage to property or other violations in accordance with the Match Management Regulations, the parties involved must bear the cost of repairs and restore the property to its original state.
- ⑥ Abide by any other requirements requested by the organizer or organizer.



### **Article 6 (Reasons for Refusal of Sales)**

The Organizer may refuse admission to any of the following individuals in accordance with the following article:

- ① Anyone who belongs to an organized crime group or similar anti-social forces (hereinafter referred to as "organized crime group, etc."). (hereinafter referred to as "organized crime member, etc.")
- ② Anyone who has been a member of an organized crime group within the last five years.
- ③ Anyone who uses an organized crime group, etc. or an organized crime member, etc. for the purpose of benefiting themselves or a third party.
- ④ Anyone who is involved in the maintenance or operation of an organized crime group, etc., by providing funds, etc., or convenience to an organized crime group, etc. or an organized crime member, etc.
- ⑤ Anyone who has a socially reprehensible relationship with an organized crime member, etc.
- ⑥ Anyone who obtains an admission ticket for the purpose of engaging in acts in violation of Article 7.

### **Article 7 (Prohibition of Resale, etc.)**

No person may resell tickets (including through internet auctions) or otherwise obtain tickets from a third party without the permission of the organizer or organizer. However, this does not apply to resales based on special relationships with family, friends, business partners, or similar parties, without profit-making intent, and not conducted as a business.



### **Article 8 (Refusal of Entry, Ejection, Confiscation of Items)**

The organizers may refuse entry to anyone who violates Articles 3 through 5 or who falls under the preceding article, order the person to leave the facility, and take any other necessary measures, such as confiscation of items listed in Article 3.

The organizers/organizers may seek compensation for all damages suffered by the organizers/organizers from anyone who falls under the preceding paragraph.

The organizers/organizers may refuse entry to any person who falls under the preceding paragraph and is deemed to be particularly malicious, from all future matches in which FC Machida Zelvia plays (including matches hosted by J.League and other organizations).

The organizers/organizers may also demand the return of their tickets.

The entry ban and other penalties set forth in the preceding paragraph may apply not only to matches hosted by FC Machida Zelvia, but also to other J.League and other organizations' matches.

Anyone who is denied entry or ejected from the facility by the organizers/organizers cannot request a refund of the ticket purchase price.



**In addition to the above match management regulations, FC Machida Zelvia also prohibits the following actions:**

- Using loudspeakers for purposes other than cheering control
- Group protests, bus blocking, and other disruptive behavior
- Using duct tape when displaying banners
- Intentionally reserving seats or reserving spaces using flags, sheets, etc.
- Entering the visitor supporters' section while wearing FC Machida Zelvia merchandise
- Entering areas other than the designated area while wearing visiting team merchandise
- Watching games while wearing uniforms or merchandise from other J.League clubs that do not feature the jersey numbers or names of FC Machida Zelvia players. \*Uniforms of teams that FC Machida Zelvia players previously played for are permitted.
- In principle, cheering or watching games with an open umbrella
- Wearing masks or other items that officials determine make it difficult to recognize individuals' faces
- Using noisemakers or other items that officials determine may cause a nuisance to local residents after 9:00 PM.  
\*Times may vary slightly.



- Cheering outside the stadium without permission from the organizers
- Watching or cheering while standing on a chair
- Sitting or straddling a fence or handrail
- Leaning over a fence or handrail to watch or cheer
- Leaning over or putting your feet on a fence or handrail
- Covering, destroying, damaging, or manipulating banners, etc. without permission from the owner or organizers
- Disrupting order within the stadium
- Running around the stadium
- Acts that the organizers or organizers deem disruptive to other spectators
- Swearing or slandering opposing players or referees

### VISITOR GATE

- Away Supporter's Area

## ■ How to enter

Please present your ticket at the appropriate gate.  
Please cooperate with baggage inspection.  
Gates open two hours before kick-off.

### Attention

Nozuta Park opens at 6:00 AM. Please refrain from entering before then.  
Staying overnight the night before, or erecting or using structures without permission from the facility management, organizers, or supervisors is prohibited.



# Visitor team merchandise area



## Attention

Wearing visitor merchandise or cheering in prohibited areas is prohibited.  
If you are found doing so, you will be asked to remove or hide the merchandise.



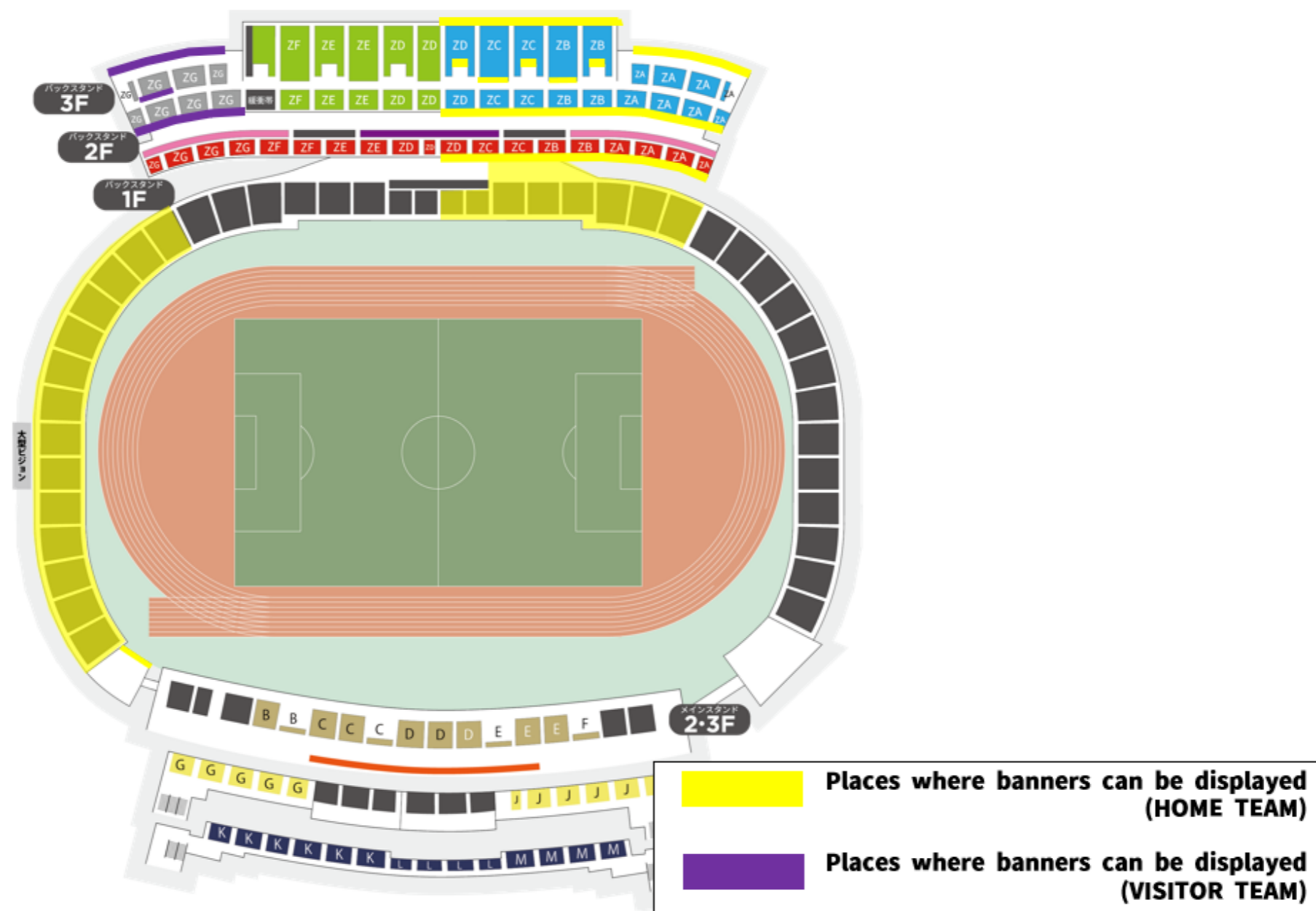
# Rules for cheering on a team

- Watching the game using noisemakers such as drums and loudspeakers, or standing up, is permitted in the Away supporters' area.
- The use of noisemakers and standing spectators are prohibited in Main Stand.



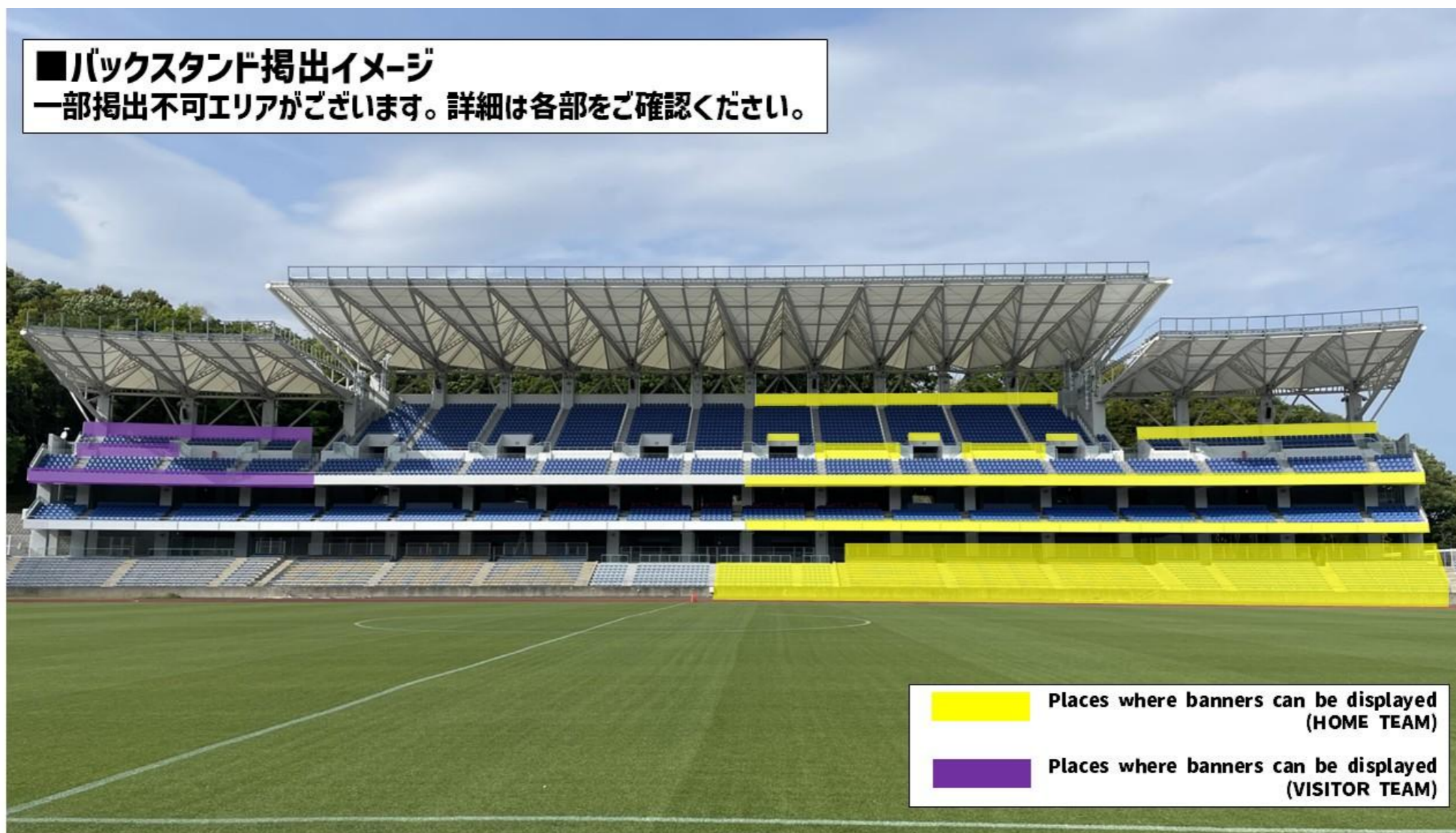
# Banner and large flag display areas

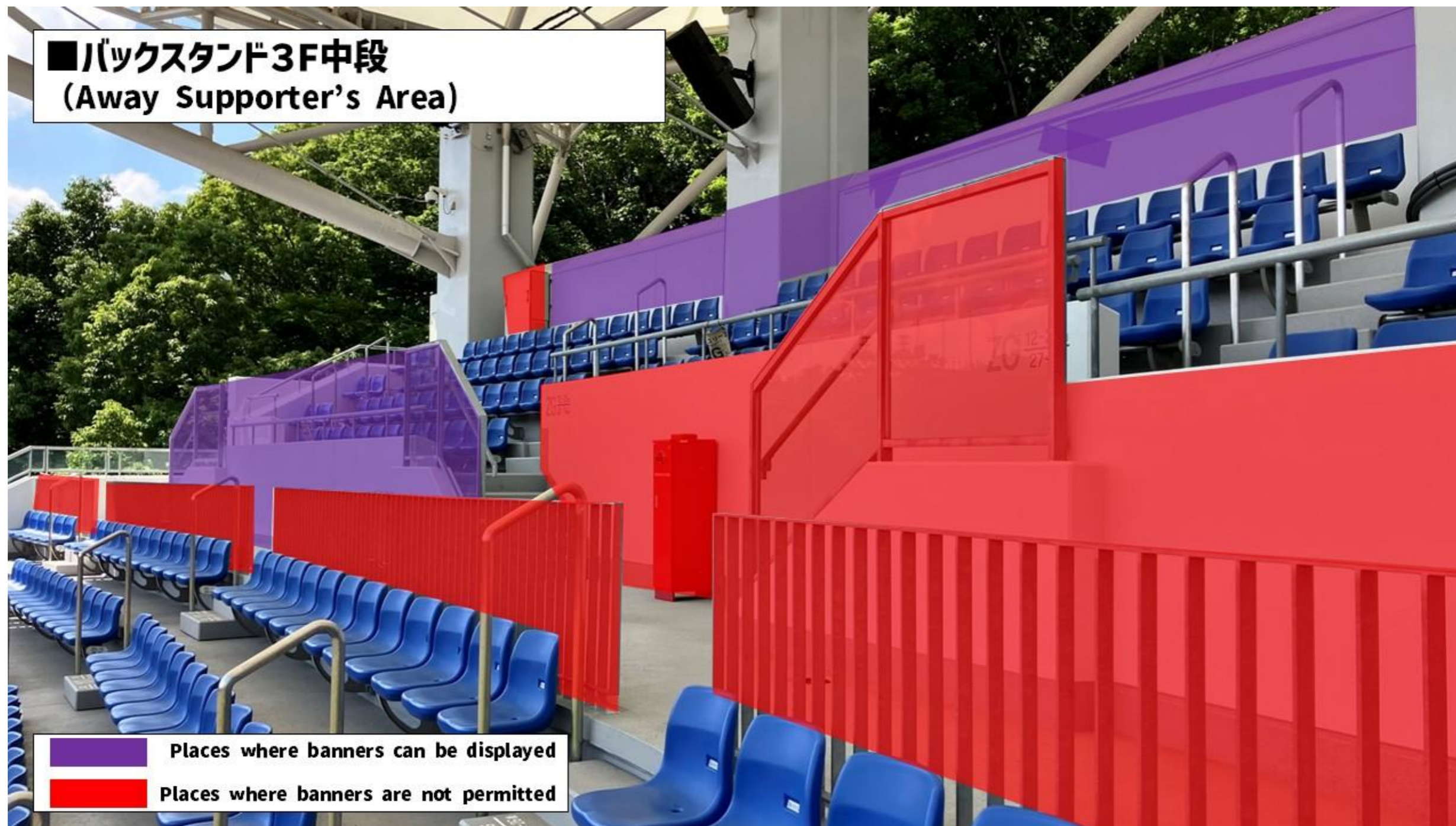
## Attention

- Displaying banners and other items is permitted only in designated areas. Displaying or posting in other areas is prohibited. If banners or other items are displayed outside of the designated areas, the organizers and officials may remove them. Please be aware that no compensation will be provided for any incidents that occur during the removal of banners or other items.
- Viewing the match from anywhere other than your seating area or entering any area other than the viewing area is prohibited.
- Any behavior that the organizers and officials deem to be a nuisance to other spectators is prohibited.
- Continuing such behavior may result in you being asked to leave the stadium.

# Banner and large flag display areas

## ■バックスタンド2F・3F最前部 (Away Supporter's Area)

Please make sure the sign is aligned with the concrete area.  
If the bottom of the front part of the 3rd floor protrudes from the concrete, please bend it to the width of the concrete and tie it to the pillar on the 2nd floor.  
The width of the concrete is approximately 80cm.

## Regarding display of banners

① Visiting teams can display banners after the stadium opens.

\*Around three hours before kickoff, our club staff will inform cheer leaders of stadium rules (such as where to carry banners), so please be at the visitor gate.

If you are not present, we will observe the situation on-site and explain the rules.

[Attention]

- Banners cannot be displayed outside of designated banner display areas.
- Due to the structure of the stadium, there are limited areas where banners can be displayed. We ask for your cooperation in displaying banners in a considerate manner.
- Banners cannot be displayed in areas that cover sponsor signs, stadium advertisements, or stadium facilities (large screens, emergency lights, fire extinguishing equipment, etc.).
- The use of duct tape is prohibited. If you use tape, please use masking tape.
- Banners (including flags, banners, etc.) that contain libel, slander, racism, advertising, or content that violates public order and morals, or that otherwise constitute inappropriate content for a match venue, are prohibited from being brought in or displayed. If the organizers or supervisors determine that a banner or other item falls into any of these categories, the displayer will be required to remove it themselves. If the displayer is unknown or refuses to remove it, staff will remove it. In such cases, no compensation will be paid to the displayer even if the banner or other item is damaged. We ask for your understanding. Furthermore, if this occurs, the displayer may be asked to leave the stadium even if the match is still in progress, or may be denied entry to future ACL and J.League official matches.
- Please follow the instructions of on-site staff regarding the location and method of displaying banners.



## Regarding the use of large flags

- Large flags used to support the visiting team are prohibited in seats within the away supporters' area.
- If flags are used, they must be no larger than 101.5cm in height and 157.5cm in width.

If you want to waving flags, please use flags that are no larger than 101.5cm height and 157.5cm wide.

- When flying a flag, please make sure it is no larger than 101.5cm in height and 157.5cm in width.
- Any behavior that the organisers or organisers deem to be a nuisance to other spectators will be prohibited. Continuing such behaviour may result in you being asked to leave the venue.
